Portfolio management and ESG integration

Equity and fixed income

Analysis of a company's ESG policies and practices are important inputs when assessing its long-term viability. At CIBC Asset Management, fundamental credit and equity analysts perform in-depth assessments of companies. Their primary goal is to value investments and drive alpha ideas for both fixed-income and equity portfolios. We believe an analysis of ESG risk factors is fundamental to the accurate valuation of a company's equity and debt securities. A comprehensive assessment of the risks and the range or magnitude of potential outcomes associated with company valuations is also critical. By combining both financial and ESG risk analysis, we produce a deeper understanding of the companies in which we invest.

To facilitate the consistent and robust application of research into ESG factors, we have implemented a rigorous procedure to integrate ESG factors in our fundamental analysis and investment process. As part of our analysis, we incorporate ESG risk assessments on companies to determine how ESG risks are being managed at the company level. These assessments utilize a proprietary materiality model that leverages data to identify potential investment risks in our coverage universe. Our analysts and portfolio managers rely on their deep expertise of the companies in which we invest to determine the financial materiality of these risks and fully incorporate these views into our holistic assessment of each investment opportunity.

Our global sovereign ESG framework is consistent with our disciplined top-down investment process implemented across all of our macro investment strategies. This process rigorously integrates quantitative inputs with qualitative fundamental research. Macro ESG investing is no different.

We integrate:

- 1. Quantitative scoring of ESG risk factors
- 2. Qualitative assessment of economic risk factors, sovereign idiosyncrasies and ESG dynamics

We've developed a proprietary quantitative process to grade countries across ESG dimensions. In addition, a qualitative overlay is provided by our analysts based on their regional macroeconomic, fiscal, and monetary policy knowledge.



We believe that the integration of ESG factors into fundamental investment analysis results in deeper, more thoughtful research, contributing to better outcomes for our clients.

3.3 Portfolio manager due diligence and research

Our Total Investment Solutions (TIS) team is responsible for researching potential portfolio managers to guide existing or upcoming investment mandates. TIS uses a comprehensive process to evaluate manager best practices in the following categories when determining if a manager is suitable for an investment mandate:

- · Organization of the firm
- Investment staff
- Decision making
- Idea generation
- Security selection
- Sell discipline
- Research
- Portfolio construction

In addition to a fundamental manager assessment, our TIS team performs, in collaboration with the Sustainable Investments team, an in-depth ESG due diligence of all prospective and existing managers. The process culminates in an overall ESG rank for each firm. At its core, the assessment is focused on identifying how ESG and responsible investing principles are integrated into the firm's culture and investment process. The team looks at the following categories during the ESG due diligence:

- ESG integration process
- Active ownership policies/practices
- Dedicated resources
- Industry collaboration
- Incentives and compensation

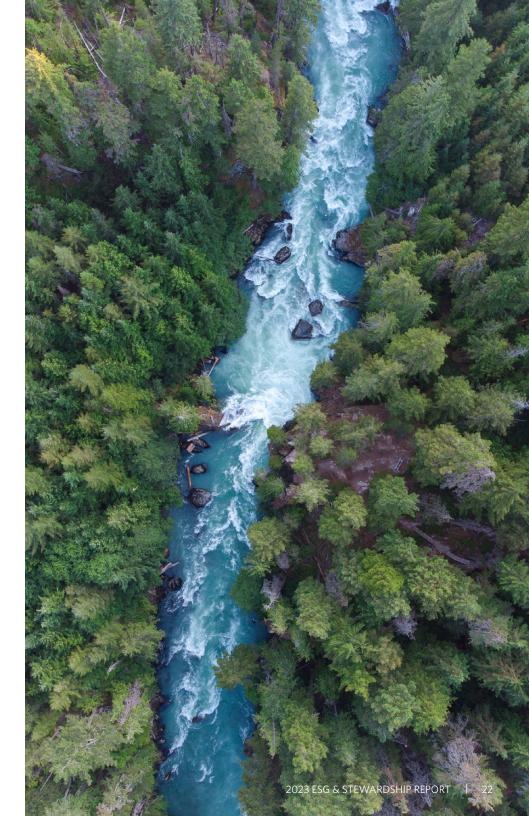
We encourage our sub-advisors to further integrate ESG factors into their investment processes and procedures. We encourage their adherence to the PRI when these conditions are not currently being met.

3.4 Exclusions

CIBC Asset Management adheres to all regulatory requirements to exclude securities required by domestic and international law. We do not have any values-based exclusions that apply firm-wide. For certain strategies with values-based exclusions outlined in the investment policy, we partner with external data providers to construct the investment-approved lists on a monthly basis. These strategies have publicly available frameworks that establish the process and revenue thresholds for all exclusions.

3.5 Case study

Our policy in action: ESG integration approaches among asset managers

With a significant increase in adoption over the past few years, more asset managers are developing the knowledge and capabilities for integrating ESG factors within their investment processes. As stewards of our clients' capital, it is critical for CIBC Asset Management to monitor and research the investment capabilities of our subadvisors. The scope of this exercise has expanded in recent years to include an assessment of firms' ESG integration policies and practices.

Our belief is that an assessment of ESG risks and opportunities is additive to the investment process. Considering a company's performance on factors like climate risk, health and safety, or internal controls provides a more robust picture of risk and opportunity. By extension, company management's views on these factors are also critical to assess, as they can shape long-term capital allocation, overall strategy, or response to controversies. For these reasons, engagement and active ownership is another important piece of the process.

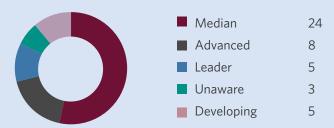
At CIBC Asset Management, our manager research process includes an annual assessment of subadvisor ESG capabilities. This is operationalized through our annual ESG survey, which must be completed by all current and prospective subadvisors. Our framework focuses on the policies, procedures, and expectations related to the investment professionals at our subadvisor firms, rather than a holdings-based approach which can involve materially different starting points driven by factors such as asset class, investment style, or geography. We consider five specific areas within our annual evaluation, and conduct follow-up meetings with each of our subadvisors to clarify responses, gather additional details, and learn more about upcoming initiatives. We believe these specific ESG engagement meetings provide valuable insights into how responsible investing is ultimately being implemented at our subadvisor firms.

With over 40 external portfolio managers having a relationship with CIBC Asset Management or CIBC Private Wealth, the breadth of our assessment is quite large, allowing us to identify emerging trends within the Canadian and global asset management industry. While the specific approach to ESG integration differs among most firms, there are observable trends in the responses we received in 2023, particularly from leaders in the sustainability space.

3.5 Case study (cont'd)

Focus on climate risk

Climate is increasingly being regarded as a material systemic risk for companies across geographies and sectors. While short-term climate risks can be influenced by regime changes and government policy, the long-term shift away from fossil fuels is being seriously considered as both a risk and opportunity for companies. While the International Energy Agency (IEA) projects global oil demand to peak before 2030, investment into renewable capacity is constantly accelerating, and global climate commitments from corporations and governments are increasing. These factors can all influence the long-term profitability of companies, and investors are increasingly building the capabilities to model potential outcomes under a range of scenarios at both the company and portfolio level.

In response, asset managers are beginning to develop dedicated risk analysis tools to aid in climate analysis. By leveraging different assumptions around variables like pace of renewable adoption, changes in government policy, or potential costs associated with climate events, asset managers are able to research the potential impacts to their portfolio and investee companies under several scenarios. Factors like stranded assets, emissions caps, or carbon taxes can have direct impacts to company fundamentals over the long term.

Outcome-based active ownership

In response to increasing investor expectations, asset managers are devoting more time and resources to stewardship activities within their portfolios. This is manifesting in several different ways, including:

- Thematic engagement campaigns centered around specific issues such as climate or diversity across their entire portfolios
- More participation in collaborative engagement organizations
- Developing a milestone framework for assessing company progress on issues raised in previous engagement meetings

In addition to a more robust stewardship approach, we are also seeing more formal escalation processes where managers are taking definitive action when their concerns are not being met effectively. In cases where progress is not being made, managers are increasingly filing shareholder resolutions and voting against directors.

Less reliance on third-party ESG ratings

Completeness, reliability, and timing of sustainability data has often been cited as a primary challenge for the effective implementation of ESG integration. In response, various data providers stepped in to fill this void by compiling available data and calculating 'ESG ratings' for the universe of public companies, allowing investors to effectively outsource their ESG research. However, these data providers use different methodologies, data points, and category weights which results in a very low correlation between ESG ratings from various providers, and limited insights for investors on the potential financial implications of an issuers' ESG risk and opportunity set.

In recent years, we have seen a significant shift away from third-party ESG ratings being used as a decision making input. Asset managers are developing their own internal frameworks for assessing ESG risks and opportunities, consistent with their own views on financial materiality and investment style. We view this positively as it promotes more thoughtful research around sustainability factors rather than defaulting to a single data point that aims to capture the full spectrum of risks and opportunities that a company may be faced with over the long term.

Note, while the reliance on ratings may be trending downwards, these data providers still play an important role in driving ESG integration efforts across the industry by providing raw sustainability data and developing ESG specific passive or quantitative strategies based on ratings or other data points.

In conclusion, while the specific approaches used by asset managers can significantly differ, the one common theme across the industry is progress. Investor expectations are evolving, and asset managers at the forefront of this evolution are well positioned to deliver on their clients' expectations moving forward.

4.1 Climate policy

CIBC Asset Management supports the Paris Agreement and we acknowledge the scientific evidence of climate change. We are cognizant of the future implications it may have on our clients' assets. As a result, we've formally accepted that climate risk is investment risk, and we're diligent in assessing climate risk as an extension of our fiduciary duty.

The impacts of climate change carry both short- and long-term implications for investment returns. Regulatory changes, the transition to a low-carbon economy, and changing weather patterns will expose companies to both physical and transition risks.

It will also provide secular growth opportunities for innovative firms. We'll continue to evaluate the materiality of these factors with our investee companies and will engage with them when appropriate.

Our approach

The materiality of climate-related risks and opportunities varies by company and industry. We assess all of these factors on a case-by-case basis within our fundamental, bottom-up company research process. The conclusions reached are an important input into the overall investment thesis and contribute to company valuation and portfolio construction decisions. Investment team members have a responsibility to identify relevant climate factors, the financial implication of any material risks or opportunities, and to communicate their findings to the team.

We favour an active ownership approach to investing in fossil fuels, rather than divestment. This enables us to identify areas where companies may be lagging, and to work with management on developing an appropriate response. This ongoing dialogue facilitates a greater understanding of the company's business model, strategy, and challenges. We also recognize that some heavy-emitting companies will have a significant role to play in our transition to a low-carbon economy. We'll encourage them to adopt emissions reduction strategies where applicable. We also commit to being active participants in collaborative engagement efforts to encourage best practice adoption at some of the highest emitting corporations in Canada.

Alongside engagement, proxy voting is a critical part of our climate stewardship process, and is one of the most important ways in which we act in the best interest of our clients. We aim to support a strong culture of transparency and action as it pertains to climate-related resolutions, and will consider each vote on a case-by-case basis.

We believe that climate risk is investment risk, and that there are both shortand long-term implications for the investment industry. This policy applies to all asset classes at CIBC Asset Management and covers all investment staff and actively managed investment products. Passively managed investment mandates, such as index mutual funds, and quantitative strategies, such as multi-factor solutions, are excluded. Climate change is an evolving issue, and we're committed to reviewing this policy on an annual basis in order to be prepared for future developments, and to enable us to act in the best interests of our clients.

Climate Engagement Canada

In 2021, we became a founding participant of Climate Engagement Canada—a finance-led initiative that encourages dialogue between the financial community and corporate issuers to promote a just transition to a net-zero economy.

As a signatory of the Canadian Investor Statement on Climate Change, we recognize that climate change presents a major threat to long-term growth and prosperity. Accordingly, there is an urgent need to accelerate the transition towards a net-zero economy.

Climate Engagement Canada in action

Mining company: The equity team met with several key stakeholders at the company to discuss next steps in the company's climate change strategy. This meeting followed a previous engagement that was performed with the company on this topic.

During the meeting, CIBC Asset Management voiced our preference for the company to develop more robust upstream scope 3 emissions disclosures. The company acknowledged that it has more work to do to in measuring and reporting these emissions, and is actively working to complete that process. The team also pushed for a phase-out plan for the company's coal-fired power plant in Panama, and an electrification plan in its mines currently running on diesel fuel.

The team enquired about capital spending and allocation to decarbonization efforts, and what the company's plan is for long term emissions reduction. The company acknowledged that power decarbonization is a strategic objective, and are looking at several initiatives to facilitate that reduction, such as shifting their entire fleet into electric vehicles (EVs). Finally, after the company indicated that it has not engaged any external experts on climate change to advise, we encouraged the company to leverage external expertise to help shape its future strategy around decarbonization.

4.3 Disclosure and reporting

Our analysis of climate-related impacts to our portfolios began in 2019 with the creation of a working group tasked with identifying risks and opportunities, both physical and transition-related, to climate change. The outcome was an initial stress test to estimate how various climate change events could impact securities valuation through damages, costs and stranded assets.

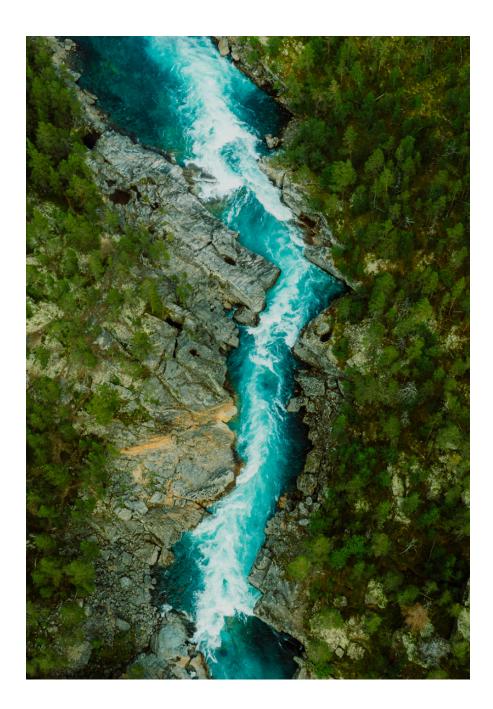
Building on our ambition to increase the transparency of our ESG and climate disclosures, CIBC Asset Management published its first climate report in 2023. Following the recommendations laid out by the Task Force on Climate-Related Financial Disclosures (TCFD), we established formal governance structure, strategies, policies, and procedures related to climate risk within our portfolios.

We believe that climate risk is investment risk, and that there are both shortand long-term implications for the investment industry. Regulatory changes, the transition to a low-carbon economy, and changing weather patterns will expose companies to both physical and transition risks. They will also provide secular growth opportunities for innovative firms. We integrate climate change considerations into our investment processes, including risk management, fundamental analysis, and engagement with portfolio companies.

While climate change is a continually evolving area, we will continue to develop the resources, capabilities, and intellectual capital to assess and integrate climate-related risks and opportunities into our ESG integration framework.

5.1 Engagement—a vital part of our investment process

We acknowledge that stewardship is an essential part of our fiduciary duty. We focus on direct interaction with management and engage on a variety of issues including strategy, financial performance, capital structure, and ESG risks and opportunities. A substantial portion of our company research is informed by direct, persistent contact with company management and boards of directors, both in meetings and visits to operations. Portfolio managers and analysts have a shared responsibility for ongoing dialogue with investee companies under coverage. This ongoing dialogue is a key element in effectively implementing our stewardship responsibilities and informs the investment decisions we make on behalf of our clients.

We engage with issuers across both equity and debt markets, leveraging our expertise across the capital structure to most effectively identify key priorities for engagement. We select issuers based on the size of our ownership position and our relationship and access with company management. As a result, we have a greater ability to engage with Canadian issuers.

We focus on two types of engagement. They're centered around strategic priorities for our organization and ad hoc engagements led by ESG risks identified at the issuer by our portfolio managers and analysts. Through our proprietary ESG analysis and deep understanding of the companies and sectors, our team is equipped to identify material factors facing our investee companies. We work with their management teams to ensure appropriate steps are being taken to mitigate those risks. We take a stakeholder approach, recognizing that companies have a duty to both the shareholder, and the communities and societies within which they operate.

We believe that divestment is a last resort, as we lose our opportunity to influence the sustainability practices within the company and industry.

Number of corporate issuers with ESG coverage

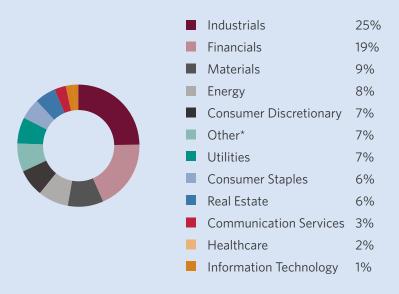

5.2 Engagement in action

Example #1

Healthcare company

The Equity team met with a Japanese health care company late in 2023, after the company was hit with repeated US Food and Drug Administration (FDA) warnings on quality assurance (QA). In our view, the company's response and actions taken were not satisfactory. The meeting was solely focused on identifying the root cause of the QA problems, what specific actions are missing to satisfy regulators and investors, and the potential risks to their business if they are shut out of the US market. After the meeting, we left with a clearer picture as to what challenges are being faced, and believe that the company is adequately resourced to ultimately overcome the FDA warnings. In addition, the company reworked their compensation structure to include QA in the performance metrics for management, which we believe will lead to greater accountability and oversight moving forward.

Example #3

Energy company

The Equity team met with members of the board to discuss the company's ESG strategy and progress, as well as executive compensation. The team enquired about the company's approach for cybersecurity and discussed the various protocols in place in case of a cyberattack. We better understood the company's progress on their inclusion initiatives, and how ESG metrics are incorporated into senior management's overall compensation. Finally, we raised questions around the company's ESG disclosures, particularly in the Environmental performance and target area, and encouraged the company to set more relevant and more aggressive targets next year.

Example #2

Technology company

The Equity team met with members of the board to discuss key ESG issues impacting the company, including lack of board composition, executive compensation, and overall governance. During the meeting, the team strongly recommended board action to reduce the leverage profile of the company, communicated our concerns around recent elevated M&A activity, and encouraged the company to improve its representation of women. Subsequent to our meeting, the company nominated two new independent board members, including one woman, which puts gender diversity at the board level at 29% (2 out of 7), just below our strategic threshold of 30%. We will continue to closely monitor the board composition of the company and any new sustainability developments.

Example #4

Government consultation

The Fixed Income team participated in structured consultations around the inclusion of nuclear in the Government of Canada's Green Financing Framework. Discussions centered around the role of nuclear in meeting domestic decarbonisation goals as well as strengthening Canada's energy security. The team voiced their preference for the inclusion of nuclear within the framework, as we believe it will drive greater issuance of labelled bonds in Canada while also contribution to domestic emissions reduction. Ultimately, the Federal Government modified its framework in late 2023 to include nuclear technology.

5.3 Proxy voting

Proxy voting is a critical part of our investment process. It allows us, as investors, to express our views on the governance of the companies in which we invest. In addition, it's one of the most important ways in which we act in the best interest of our clients. We aim to support a strong culture of corporate governance, effective management of environmental and social issues, and comprehensive reporting according to credible standards.

We actively engage in proxy voting decisions. Our analysts and portfolio managers coordinate discussions and messaging with company management and boards of directors, and are responsible for reviewing and voting the proxies in their coverage universe. The proxy analysis and recommendations provided by our third-party proxy advisor are starting points for further review, guided by the issues at hand.

In order to facilitate the logistics of the proxy voting process, our portfolio management and research team ensures that the instructions on base-case voting guidelines from our third-party advisor best reflect our evolving views on governance standards and sustainability.

We spend the majority of time on proxies we can have the greatest impact on, either through the size of the ownership position or the strength of our relationship with the company. As a result, we will place greater reliance on the proxy advisor for international investments.

5.4 Proxy voting in action

Proxy voting example: Canadian utility company

Part of our role as active owners involves manual review of our voting guideline recommendations for resolutions deemed to be material. In cases where CIBC Asset Management has a large ownership percentage, or for contentious voting issues, our analysts and Portfolio Managers make active decisions, which can result in votes against our base-case voting guidelines. This situation can be illustrated by our votes against a director for a Canadian utility company. While voting guidelines recommended a vote 'for' the individual, CIBC Asset Management elected to vote 'against', based on a thorough review of the candidate's poor track record on the boards of several competitors.

In 2023, we voted 'against' base-case policy guidelines 90 times, highlighting our commitment to active ownership and to deep research into the nuances of our investee companies.

6.3 Our commitments (cont'd)

30% Club Canada

The 30% Club Canada challenges board chairs and CEOs to achieve more reflective leadership at the board level and in the C-suite positions.

CIBC Asset Management is a signatory of the 30% Club Canada and its **Investor Statement of Intent**. This commits us to exercising our ownership rights to encourage gender-balanced leadership on corporate boards and in executive management positions in Canada.

30% Club Canada in action

Canadian retailer: After several engagements from CIBC Asset Management and other participating shareholders, one of Canada's largest retailers has made significant progress across their board composition and inclusion initiatives. In 2023, the company introduced a gender diversity policy with a 30% goal for women representation, and elected two additional women to the board, bringing representation up to 31% after being below this threshold for several years.

CIBC Commercial Banking and Wealth Management **Inclusion Scholarship**

This scholarship is open to those who identify as members of the Black community or as First Nations, Métis or Inuit peoples. Up to six scholarships are available. Successful applicants receive \$10,000—paid directly to their educational institution—and a paid summer internship with CIBC Commercial Banking and Wealth Management.

Chartered Financial Analyst (CFA) Scholarship for **Indigenous Peoples**

Our ambition is to increase Indigenous representation in the financial services industry. Through granting our annual **CFA scholarship**, we are looking to equip the next generation of Indigenous professionals with financial knowledge and resources needed for growth in their careers. We were proud to award two scholarships in 2023.

Ivey Women in Asset Management Scholarship

We're proud to have a three-year partnership with the Ivey School of Business Women in Asset Management



Women in Asset Management

Program. This 14-week program offers both in-class and a paid 10-week internship experience, designed to overcome the underrepresentation of individuals who self-identify as women in asset management. Students in the program gain meaningful asset management experience and an introduction to industry career opportunities.
